GENERAL TERMS & CONDITIONS: Please read this agreement carefully before sending any money.

Tour Cost: The price of the ETV Endowment Canadian Rockies Tour is \$5,749 per person, ground only. This price is based on double-occupancy, and a minimum of 25 persons. The tour price includes a \$750 tax-deductible contribution to ETV Endowment. Single supplement is \$1,390. See note under Accommodations on the reverse.

Tour Cost Includes: \$750 tax-deductible contribution to the ETV Endowment • Seven (7) nights accommodations • Breakfast daily, five (5) lunches and four (4) dinners including Welcome and Farewell Dinners • All trip activities as listed in the itinerary • Private coach transfer from Calgary and to Edmonton airports • Private guides for all activities mentioned in the itinerary • Services of Destination Southwest tour director Sally Lane throughout the tour • All gratuities for meals, bus drivers, local guides and tour director • Baggage handling for one piece per person for hotel transfers • One ETV Endowment luggage tag

Tour Price Does Not Include: Single supplement of \$1,390 • Airfare from the US to Canada and return • Meals and activities not offered as part of the tour • Alcoholic beverages not part of tour-included meals • Tips for hotel maids • Personal expenses and purchases • Personal and travel insurance

Reservations and Method of Payment: The deposit for the tour is \$750 per person, first come, first served. Payment is accepted by check made out to ETV Endowment of South Carolina or credit card (Visa, MasterCard, AMEX, or Discover). The deposit is non-refundable unless the trip is cancelled by ETV Endowment.

Final Payment: The first ½ payment is due on <u>February 26, 2021</u>. The final balance must be received at ETV Endowment by <u>Friday, March 30, 2021</u>.

Rates: Prices could increase due to below minimum participation. Participants will be notified of any such price increase at least 90 days prior to departure.

Cancellations: Travelers are entitled to a full refund if the tour is cancelled by ETV Endowment or Destination Southwest (see attached Covid-19 Travel Policy). If a traveler should cancel prior to the first balance payment date, the \$750 deposit is non-refundable. For traveler cancellations after the first balance payment date, there is no refund, except in instances when a substitution occurs. Notice of withdrawal from the tour must be communicated to ETV Endowment by e-mail: araffo@etvendowment.org or by mail. All cancellations will be confirmed by Amy Raffo at ETV Endowment.

No refund will be given for any traveler who, for any reason, does not arrive for either airline or vehicle departure. No refund will be made for features the passenger opts not to use. Once travel begins, any change made by a traveler is the responsibility of the traveler. Cancellation penalties caused by accident or illness to a traveler do not constitute waiver of applicable fees. Refunds will be processed within 10 days of receipt of cancellation notice. No person outside the group may participate in tour activities, including transportation and meals, unless he or she is admitted under the full tour cost.

Itinerary or Program Modifications: While every effort will be made to adhere to the tour itinerary as planned, ETV Endowment and Destination Southwest reserve the right to modify the itinerary or programs at their discretion as warranted by circumstances at the time of the tour, including the right to substitute hotels of similar quality. In the event of any changes, ETV Endowment and Destination Southwest will work to substitute programs of comparable value.

Accommodations: Hotels are chosen for comfort, location and character. Please be advised that not all rooms are alike and may differ in size.

Transportation: Participants are responsible for booking air travel. Travelers arriving or departing on other dates or from other destinations will be responsible for meeting up with the group in Calgary and for any fees incurred by these arrangements. Tour participants should be at Calgary International Airport on June 19, 2021, before 5:00 PM. The ETV Endowment is not responsible for any expenses and/or damages incurred due to weather and/or flight delays. Any additional costs incurred outside of the set guidelines will be the sole financial responsibility of said traveler.

Travel Insurance: Because cancellation policies are strictly enforced, we strongly recommend for your protection that you purchase trip cancellation insurance. Travel insurance is also highly recommended in order to protect participants who must cancel or interrupt their trip due to illness or injury. ETV Endowment does not sell trip cancellation insurance.
